3. Information of alteration to the Certified Service Operation System:

In case any alteration to the certified service operation system of the firm is made, such alteration shall be reported to DNV, immediately.

Intermediate/Renewal Audit:

- a. Renewal of the certificate shall be made at intervals not exceeding three (3) years by verification through audits that approved conditions are being maintained.

b. Intermediate audits may be required by DNV as found necessary.

c. At least 3 months before the period of validity expires, the supplier shall apply to DNV for renewal of the Certificate of Approval.

CANCELATION OF APPROVAL:

Approval may be cancelled in the following cases:

1. Where the measurements were improperly carried out or the results are improperly reported.
2. Where a surveyor finds deficiencies in the approved service operating system of the firm and appropriate corrective action is not taken.
3. Where the firm fails to inform of any alteration as stated in item 3 of approval conditions.
4. Where willful acts or omissions are ascertained.
5. When new rule requirements make this necessary.

It is generally not required to have the name of approved supervisors and technicians listed or identified on the certificate. It is obligation of the company to follow their approved training programme and assign the tasks to the qualified personnel as required. The supplier shall maintain and update the list of supervisors and technicians based on the requirements. Any changes to the list shall be clarified with DNV. DNV reserves the right to require a new evaluation of the company based on the changes on the list.
